As we move closer to the preparation of the 2022 budget, we will be finalizing our analysis of the long term needs for our Capital Reserves and developing proposed strategies for adequately funding these needs.

Important: Fire Pits

The Board reminds owners that wood burning fire pits are allowed only if their use conforms to City of Bozeman ordinance, which states: "...if contained, may be used within 15 feet of a structure; if open, may only be used more than 25 feet from structure."

New Development Information

The following is a summary of CT Board President Hupka's letter sent out to owners on June 1. It is an update on the proposed residential community on the parcel of land on Ferguson and W. Babcock, which borders CT Condos to the north.

- 1. In contact with Matt Paine, developer, since the announcement of the project.
- 2. Negotiations between Paine's staff & City of Bozeman with regard to a final plan are ongoing. The plan may be finalized in the coming weeks.
- 3. Design will then be available for review on City of Bozeman website & public notice will be published. At that time concerned citizens may comment on this project.
- 4. Paine has indicated that he will host a meeting, at which time he will answer questions and address any concerns expressed by interested parties.
- 5. We will continue to communicate updates as they become available.
